

10 Flu Shots at Once

In effect more than 10 is what an average 6-month-old or 3-year-old receives compared to a 170-pound adult, since dose is not adjusted for body weight. One shot can make an adult sick, and it made my grandson deathly ill. Are they stupid or is it intentional? But, animal doses are by weight.

Safety: Only recently the flu vaccine is recommended for pregnant women, but the 2014 package insert¹ says: **“Safety and effectiveness of Fluzone has not been established in pregnant women** p.2... *Animal reproduction studies have not been conducted with Fluzone* p.11...*not known whether Fluzone can cause fetal harm when administered to a pregnant woman or can affect reproduction capacity* p.11...*not been evaluated for carcinogenic or mutagenic potential or for impairment of fertility* p.15.“

Recommendation without clear proof of safety seems **criminal** to me. With such de-

ception, can you believe any promotion of this or any vaccine? *“But evil men and impostors will proceed from bad to worse, **deceiving and being deceived.**”* 2 Timothy 3:13

Flu shots during pregnancy lead to 4,250 percent increase in fetal deaths.²

Another Epic Fail for Influenza Vaccine³
CDC caught inflating flu deaths to sell more vaccines⁴

“Data evaluating the concomitant administration of Fluzone with other vaccines are not available” p.11., which can be far more toxic together than each alone.

Documented Side Effects: *“Guillain-Barre Syndrome, myelopathy and radiculopathy; psoriasis and psoriatic arthritis; chronic inflammatory demyelinating polyneuropathy; skin rash, fatigue, and scarring; brachial neuritis; shoulder injury related to vaccine administration, autoimmune demyelinating condition, bursitis, Bell's palsy and urticaria/angioedema; bilateral brachial neuritis; meningoencephalitis and optic neuritis; transverse myelitis, serum sickness and pain amplification syndrome of childhood fibromyalgia; acute disseminated encephalomyelitis; rheumatoid arthritis; significant aggravation of an underlying COPD and other pulmonary conditions, and death.”*⁵

Toxic Ingredients: *“Each 0.25 mL dose from the multi-dose vial contains 12.5 mcg **mercury**”* p.13, so a baby can receive over **19 times the EPA safe amount.**⁶

Formaldehyde is highly toxic to all animals, is a known carcinogen⁷, and a baby can receive about 5% the lethal dose.

*“Triton X-100... is widely used to...**permeabilize the membranes of living cells.**”*⁸ It is *“...very toxic to wildlife, particularly aquatic organisms...a long-term threat...”* It is also a known spermicide.¹⁰

Also the FDA can approve unlabeled ingredients, so who knows what else there is.

They claim there is no research supporting the vaccine/autism link, but here is a list of 100+ research papers supporting such link¹¹ For how many years did they deny a smoking/lung cancer link?

Effectiveness: *“...Every year, hundreds of thousands of respiratory [flu] specimens are tested across the US. Of those tested, on average 16% are found to be influenza positive.”*¹² So 84% of “flu” is missing the flu virus, the only thing the vaccine combats. Proponents own figures show it prevents flu in only 1.5 of every 100 adults.¹³ Why accept the grave risks for so little?

The package insert first says that specific levels of antibodies from the vaccine **“have not been correlated with protection from influenza...”**p.14.” Then they measure the effectiveness of the vaccine by how much antigen it produces (not by how much it reduces the incidence of the flu). So, their assertions of effectiveness are **not based on clinical evidence.**

Furthermore they say “*In some human studies, antibody titers $\geq 1:40$ have been associated with protection from influenza illness in up to 50% of subjects*”^{p.14.} In other words, in a few studies (but not *many* or *most* or they would have said so), the best result they could find puts an upper limit of 50% for effectiveness. But, how effective and how did they measure it?

Finally to make matters worse, they discuss how effectiveness will be less if the antigen of the vaccine does not match the particular flu virus, since the viruses mutate, etc., etc, which they admitted happened in 2014-15.

So the most they can say is: “*The best way to prevent the flu is by getting vaccinated each year.*”¹⁴ But I am sure the greatest protection is a strong immune system, which is only from God's nutrition and vitamins.

Motivation: Money of course is the great driving force of it all, and I am sure the vast majority are simply trying to do good and earn a living, honestly believing vaccines are beneficial. The **Georgia Guidestones**¹⁵ say “*Maintain humanity under 500,000,000 in perpetual balance with nature.*” **Elimination of 6.5 billion of us will happen only by purposeful action.** There is also evidence for use of vaccines for mind control.¹⁶

Vaccines certainly cause severe damage because the US “Vaccine Court” has awarded more than **\$3 billion**¹⁷, probably only a fraction of what really is deserved, since many severe cases have been denied and awards

have been insufficient, often after an arduous process¹⁸. And now, **the flu vaccine is one of the worst offenders.**¹⁹

Most important of all, the **salvation of your soul** is personal between you and God and does not depend on rites, clerics, traditions, good works, or belonging to any church or religion: “*For it is by grace you have been saved, through faith, and this is not from yourselves, it is the gift of God, not by works...*” [Eph 2:8-9](#) No matter what kind of person you are or what you have done: “*If we confess our sins, he is faithful and just and will forgive us our sins and purify us from all unrighteousness.*” [1 John 1:9](#) Pray today to put your faith in Jesus Christ alone: “*For God so loved the world that he gave his one and only Son, that whoever believes in him shall not perish but have eternal life.*” [John 3:16](#) Then study the Bible to live pleasing to God: “*...if anyone is in Christ, the new creation has come: The old has gone, the new is here!*” [2 Cor 5:17](#)
